

Communities Coming Together to Support Boulder Marshall and Middle Fork Fires

On December 30, the most destructive wildfire in the state's history broke out in Boulder County forcing thousands of residents to evacuate their homes. Although Northglenn is not a bordering jurisdiction Chief May offered police resources during the evacuation as well as in the aftermath. During the fire response Northglenn Police assisted in evacuating residents, directing traffic safely out of neighborhoods, and maintaining roadblocks to prevent entry into areas that were unsafe. Members of the Victim Services Unit assisted families at the shelters. In the days that followed, Northglenn Police responded alongside Boulder County residents to learn the status of their homes and to retrieve salvageable property. Pressing Concerns

A local resident experiencing homelessness lost his life on 12/26/21. This individual was well known in the community and his social circle will feel an impact. This resident had been battling medical conditions since he collapsed 3.5 months ago. He had found brief stability utilizing multiple programs through Colorado Coalition of the Homeless such as Beacon House and Ft. Lyons. Once exited from those programs he was offered various other programs but wanted to re-apply for Ft. Lyons as he liked it there. He needed to wait 60 days and was just cleared to re-apply the week before his passing.

Project Updates

The Winter Housing Program is well underway. The City of Northglenn is helping organize volunteers as there is high interest in lending a hand.

To date we have:

- 19 full-time participants (18 current full-time participants)
 1 exited due to the SHP operational hours not compatible with their work schedule
- Five PD Drop-offs: Assisted the following day reuniting with family (2), medical assistance (1), and offered other appropriate shelters (2)
- Provided 196 total nights of shelter for PEH
- Provided breakfast and dinner every night that the WHP has been open
- Zero calls for safety concerns
- Two calls for medical concerns

Anticipated Community Questions

Are cold weather hotel vouchers available?

SWAP will be active this year. This program is a partnership between the nonprofit, Almost Home, and Adams County. It is activated when temperatures drop below 32 degrees when it is actively snowing or raining and under 20 degrees when it is dry. How can a person enter the Winter Housing Program?

Individuals can be referred through the Crisis Response Unit or through Adams County. Appropriate referrals are for those over the age of 18, has a safe and stable place to go throughout the day, and is willing to work with case management.
