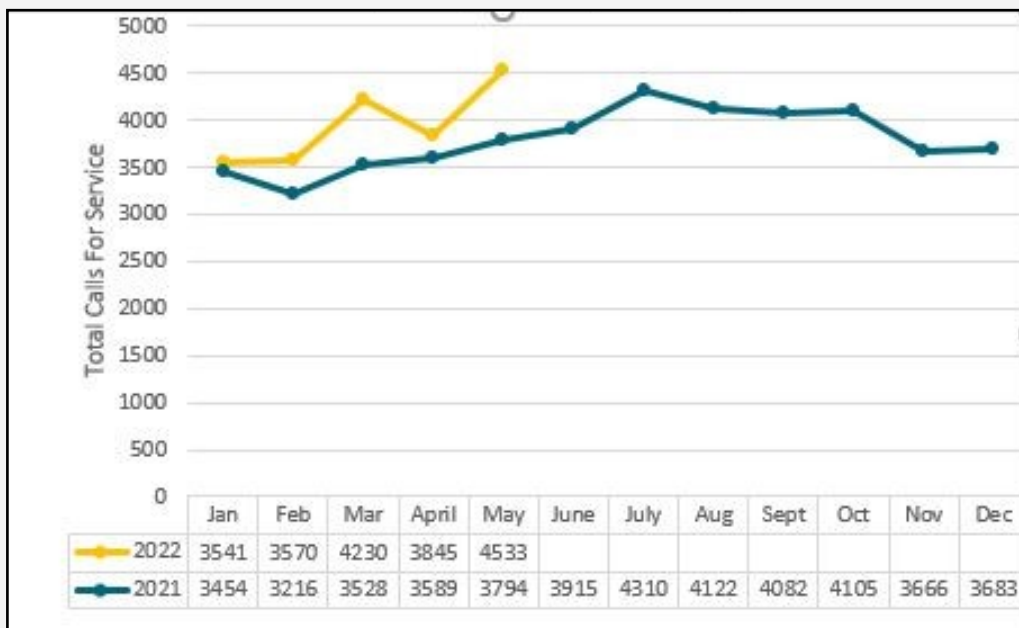

Celebrating our Senior Community

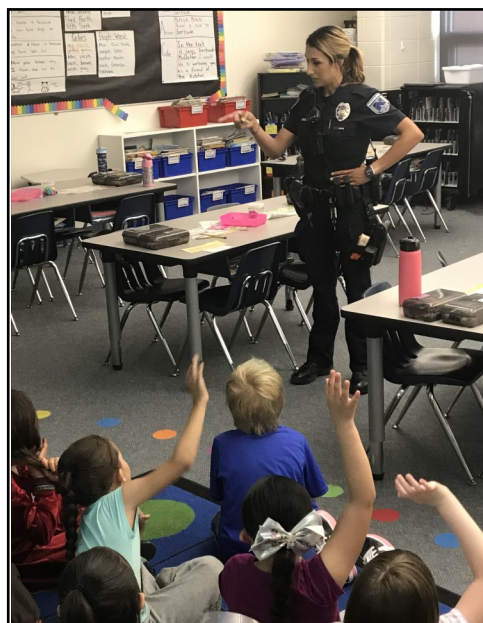

Project Updates

The Temporary Housing Program has averted a total of 2,147 night of homelessness. There have been 58 full-time participants and 10 have exited into housing from the housing program.

Friday Office Hours have been averaging 25 clients during the hours of 9-12.

Northglenn Park Rangers have been collaborating with CRU so park issues can be addressed quickly.

The CRU has been focusing on housing partnerships to assist people in and out of the Winter Housing Program.
