- Officers Prince and Schmid complete the police motorcycle FTO phase.





Updates

The Temporary Housing Program has averted a total of 2,588 night of homelessness though 6/25/22. The program is scheduled to close on 8/31/22. This month three clients have identified housing opportunities and are working on finalizing those contracts. A fourth client reunited with family and moved to North Carolina where they are housed as well.

In the Month of June, CRU responded to:

- 59 Crisis Calls
- 64 Interactions that resulted from referrals by PD, Code, and the Court

Friday Office Hours have been averaging 25 clients during the hours of 9-12 on Fridays.
