Foundation (NAHF) since 2000," said Rosie Garner, NAHF president. "We will have a showcase location that art lovers will enjoy and Northglenn residents will be proud to call their own."

The Eleanor M. Wyatt Centennial Park and Sculpture Garden will encourage visitors and Denver area residents

to visit Northglenn. The park, located at Kennedy Drive and Melody Drive, directly behind the Northglenn Marketplace, was selected as the site for the sculpture garden because of its location, ease of access and capacity to hold public art installations.

The sculpture garden currently holds four sculptures, shown above, and will eventually hold between 10 and 20. The garden will be developed over time - it could take 20 years to populate the space with sculpture.

Sculptures and installations are paid for by the NAHF through Northglenn's Art on Parade program, with major funding coming from the SCFD and other grants.



### Appropriations Bill Moves Forward

CB-1864 – Council unanimously approved a bill for a special ordinance amending the 2016 Budget, recognizing revenues and appropriating expenditures by supplemental appropriation, for the costs and expenses of the city for the fiscal year beginning Jan. 1, 2016.

CR-32, CR-33, CR 34 – Council unanimously approved the reappointments of Chandler Sanchez, Megan Smith and Mariah Witkowski to serve as members of the Board of Directors of the Northglenn Youth Commission for one-year terms commencing Feb. 23, 2016, and expiring Feb. 23, 2017.

### Waldman Appointed to Youth Commission

CR-35 – Council unanimously approved the appointment of Trinity Waldman to serve as a member of the Board of Directors of the Northglenn Youth Commission for a one-year term commencing March 28, 2016, and expiring March 28, 2017.

### Funds Approved for Sidewalks, Trails

CR-37 – In a unanimous decision, council approved the contract with Custom Concrete Cutting, Inc. for the 2016 Residential Sidewalk and Trail Replacement Program in the amount of \$81,736; and approved changes in the scope of work and relevant change orders up to the approved expenditure limit of \$100,000.

### Streets Program Funded

CR-38 – Council unanimously approved the contract with Asphalt Specialties Co. Inc. for the 2016 Residential Streets Program in the amount of \$470,970, and approved changes in the scope of work and relevant change orders up to the approved expenditure limit of \$518,067.

### Biosolids Removal Contract Approved

CR-43 – Council unanimously approved the acceptance of grant awards for the Police Department, specifically \$12,454 from the Colorado Department of Transportation Law Enforcement Assistance Fund and \$7,000 from the Colorado Department of Transportation High Visibility Impaired Enforcement program.

### Garner Reappointed to Urban Renewal Authority

CR-44 – Council unanimously approved the reappointment of Rosie Garner as a commissioner to the Northglenn Urban Renewal Authority (NURA) for a five-year term. Said term shall commence April 19, 2016, and will expire April 19, 2021.

### Fee Waived for NAHF

CR-45 – In a unanimous decision, council voted to waive the Special Event Permit liquor license fee for the Northglenn Arts & Humanities Foundation (NAHF) for the Sculpture Garden Dedication at Eleanor M. Wyatt Centennial Park on June 10, 2016.

### Truck, Mower for Parks

CR-46 – Council unanimously approved the issuance of purchase orders for city vehicles and equipment to be used by the Parks Division. Purchase orders will be issued to Dellenbach Motors in an amount not to exceed \$34,613 for the purchase of one 2016 Chevrolet Colorado Truck and to LL Johnson Distributing Company in an amount not to exceed \$35,095 for the purchase of one Toro Groundsmaster mower.

### Property Sold to CDOT

CR-47 – Council unanimously agreed to the sale of city property located on the east and west of the Interstate 25 on/off ramps at 120th Avenue to CDOT for the purpose of installing a managed lane bus access. Total offering is \$282,620.

## Education in Northglenn

### Adams 12 Looking at District Needs


Colorado continues to struggle in terms of adequately funding education. This school year alone, Adams 12 Five Star Schools is receiving almost \$1,000 less per student as a result of funding cuts from the state that started in 2010.

Additionally, the state does not provide funding to maintain our aging schools, build new schools to address overcrowding and expand space for in-demand educational programming such as Career and Technical Education.

The Five Star District spent April seeking feedback from parents and community members on how to address limited state funding, aging buildings and overcrowded schools. Through an online survey and a Telephone Town Hall event, the Five Star District was able to listen to the community and gather valuable input on next steps. The feedback will inform the Superintendent and Board of Education when deciding whether or not to seek a Bond or Mill Levy Override in fall 2016.







## Street Sweeping in May

### Residents Urged to Move Vehicles Off Streets on Scheduled Sweeping Days

In order to keep Northglenn beautiful, tidy and healthy, the city will be sweeping the streets of every neighborhood during May. It's a big undertaking, but there is a good plan in place and everyone will benefit.

It will take all of May to clean the entire city. However, crews will be in each neighborhood for just two days as they work their way across town.

**Please help by moving vehicles off the street!**

During the two-day sweeping cycle, residents should remove any vehicle, trailer or other equipment from the odd numbered side of the road on the first day, and then from the even numbered side of the road on the second day. Flyers delivered to each residence and "No Parking" signs will remind residents which day they need to clear each

side. This parking restriction is in effect from 7 a.m. to 3:30 p.m. for the two-day sweeping cycle. There is no restriction to driving on the streets.

Reasons to sweep city streets include:

1. It reduces trash and other contaminants from running into local waterways.
2. It reduces dust and improves air quality
3. It improves safety by clearing pavement markings and enhancing traction for vehicles and bikes.

The city plans to perform a full residential neighborhood sweeping program in the late fall of 2016 and again in the spring and fall of 2017.

## Northglenn Taking Care of Road, Trail and Sidewalk Repair


On March 28, City Council approved the 2016 Residential Sidewalk and Trail Replacement Program, CR-37, and the 2016 Residential Street Program, CR-38. The map to the right shows the location of the concrete, trail and street repairs that are scheduled for this summer. "No Parking" signs will be posted two days before work begins for roadway and concrete work. Please note the days listed on the signs. Listed are the affected street sections:

### Mill and Overlay – Replaces the top layer of asphalt

5. East 117th Avenue – Washington Street to dead end

### Chip Seal – Applies a new protective surface to the existing asphalt

6. Gilpin Street/Williams Street – East 105th Place to East 105th Place
7. Marion Way – East 105th Place to Marion Street
8. Grant Street – East 117th Avenue to dead end
9. East 116th Avenue – Lincoln Street to Grant Street
10. Lunceford Lane – West 99th Avenue to West 98th Avenue
11. Highline Drive – Malley Drive to East 113th Place
12. Highline Drive – East 113th Place to East 112th Place
13. Lou Drive – Fred Drive to city limits







